Today's Take-Aways

Regional Updates

• Province-wide there has been a substantial increase in the number of COVID-positive cases, and the number of those requiring acute care, with the majority in the Toronto area. Ottawa has also seen a jump in the number of acute care cases but it is still a manageable number. While these increases are impacting other health care services such as elective surgeries in some regions, the Champlain region has not yet been impacted in the same way.

Fifteen to 20 hospitals in Ontario are currently in over-capacity and according to new projections, given the current rate of spread, all ICU beds in the province could be full by February 24th if nothing changes.

Senior Leadership Team

•. We are very pleased to welcome Scott Coombes, our new Vice-President of Finance and Corporate Services (Chief Financial Officer) who took on this new role as of Monday and will be working with John Wren for the remainder of the month before John takes his leave for retirement. Scott comes to PRH with almost 20 years of experience in the business and financial world and holds Chartered Accountant and Certified Financial Analyst designations. Outbreak Status

• The two health care workers who had tested positive for COVID-19 have been given clearance dates to return to work as per direction of Occ. Health and the Renfrew County and District Health Unit.

• The majority of results from a second round of testing for those impacted by the outbreak have come back and are COVID-negative.

• We are waiting for confirmation from the Health Unit that we can declare the outbreak over.

• Staff and physicians are reminded that everyone must wear a mask when entering the hospital.

Occupational Health and Safety

• In order to make staff and physician screening, auditing and reporting more efficient a small working group will be looking at moving all staff/physician screening to an electronic-based system.

• We are pulling together a small working group to work with the Health Unit and re-examine processes and COVID safety measures which have been put in place for individuals such as vendors, contractors etc. who are coming into our buildings.

Human Resources

• Staff who reside in Quebec and work at PRH and require travel documentation during Quebec's four-week lockdown with curfew are asked to bring this request to their Managers.

Supply Status

• There continues to be a widespread supply issue with disposable gloves and our regional supply is diminishing. We are in the process of reviewing appropriate glove use, and exploring glove conservation methods where possible.

COVID Vaccine

• The province has indicated that all long-term care homes in red and grey zones will receive the vaccination by January 21st. Since Renfrew County is in a green zone, rollout to our area will likely be later. Very little information has been received about the next phase of rollout.

• If you know of any retired health care professionals who might be interested in assisting with the vaccination rollout to the general population, please provide these names to your managers as we may be looking for their assistance for that period.

EORLA (Eastern Ontario Regional Laboratory Association)

• EORLA has reported that all COVID swabs are now being tested for the new variant of COVID-19 that has come from the United Kingdom.



Renfrew County and District Health Unit

"Optimal Health for All in Renfrew County and District"

The Renfrew County and District Health Unit (RCDHU) wants to remind residents that every time a case of COVID-19 is reported, we are talking about someone who has family, friends, a job, a hobby, or otherwise contributes in some way to make Renfrew County and District a better place for all. The RCDHU works closely with each person who has either been diagnosed with or has been deemed a close contact of someone who has tested positive for COVID-19 to get a better understanding of their specific situation and how to best limit the spread of the virus.

Anyone who is or has been affected by COVID-19 deserves support and compassion from the community. RCDHU encourages people to respect other's privacy and to share positive and hopeful stories about those affected by the virus, rather than negativity or gossip.

This has been a very trying year and it's important to remember that we are not out of the woods yet. The best way to help those who are on the front lines fighting the virus, including but not limited to first responders, health care workers, and other essential workers, is to practice the important public health measures that are already in place and most important of all, be kind to each other. Our community needs to work together in order to limit the impact of COVID-19.

COVID-19 FREQUENTLY ASKED QUESTIONS

After sharing news of the recent outbreak at PRH, we have received a number of questions from staff and physicians on a variety of COVID-related topics. We have opted to address as many of these as possible in this forum so that others who may have the same questions receive the same information.

As with anything COVID-related, please note that information can change very quickly so we ask that you stay in the communication loop by reading all memos, and weekly editions of The Pulse for the latest updates.

Q: Given the provincial lockdown and recent outbreak, are there any planned changes to the Visitor Policy?

At this point the Visitor Policy remains unchanged – one visitor per patient per day. Our policy is aligned with other hospitals in Renfrew County and at this point we have not collectively been given any provincial direction or direction from our own public health unit to make changes.

Q: How should we handle visitors who are not following the guidelines that are in place?

Visitors are expected to follow all guidelines (wear a mask at all times / wash your hands / no eating or drinking) while visiting. If there any issues with non-compliance, staff are asked to alert their manager or Clinical Resource.

Q: Why are there no screening questions regarding specific travel areas or interprovincial travel?

At present there is no guidance from the province or public health to do so. Our screening questions are aligned with those in the Champlain region. In addition, regardless of where someone may have been prior to arriving at the hospital, there are many layers of mitigation for health care institutions including entrance screening, hand hygiene, universal masking and patient facing eye protection for staff.

Q: What is the plan for COVID Vaccination at PRH and when will our hospital and Renfrew County receive the vaccine?

First, contrary to what some may have heard, there has not been widespread vaccination of all staff at The Ottawa Hospital.

Ontario has identified key populations to receive the vaccine first, including long-term care and retirement home residents and the staff who provide care to these groups. Ontario will also be prioritizing the rollout of the vaccine in regions with the highest rates of COVID-19 infection, including those in Red-Control and Lockdown zones. The immunization program will focus on health care workers and the most vulnerable populations in those regions. Additionally, all adults in First Nations, Metis and Inuit populations where infection can have disproportionate consequences, including those living in remote or isolated areas, will be among the first to be offered the COVID-19 vaccine.

Our hospital has put together a COVID Vaccine Distribution Working Group which is meeting regularly and making plans for distribution based on provincial guidelines. In addition the group is making preparations for PRH to assist with vaccination rollout in long-term care home settings as required.

To date, we have been given no confirmation of when the COVID -19 vaccine will arrive for distribution in Renfrew County. We have just found out today that Renfrew County will receive the Moderna vaccine. As soon as any updates are known, we will share them with you through the regular communication channels so stay tuned!

COVID-19 FREQUENTLY ASKED QUESTIONS

Q: What is the direction for use of eye protection in non-clinical areas?

There have been a number of questions raised since eye protection has been implemented in the battle against COVID. Currently, eye protection is mandatory in all Clinical areas where the potential for interactions with patients who are not wearing a mask is the greatest risk.

Outside of clinical areas, if two metres of physical distance is maintained and/or all parties are wearing a medical grade mask, eye protection is not currently required.
